SAFETY GUIDELINES

Baby and child safety is WeeUsables' number one priority. Please carefully read the important information below to ensure the items you choose to consign meet our safety expectations.

- Please refer to the following to ensure your items are not recalled and follow our safety guidelines:

- When possible, please include owner's manuals and manufacturer-provided safety info.
- Be sure packaging for items with small pieces are sealed and contained so young shoppers are not at risk for choking or ingestion hazards while on our sales floor.
- Please no straight pins of any kind as we do not provide our shoppers with thimbles!

QUALITY STANDARDS

Most importantly, when considering items to consign, please remember WeeUsables is NOT a yard sale. **"Wee" take quality seriously.** Please leave any stained, torn, old, expired, smelly, smoky, moldy or pet-hair covered items at home. Also, per the consignor waiver, the following fees may apply:

- **\$15 – for over 15 items pulled for quality issues and for each additional 15 items**
- **\$15 – for over 15 tags that are unable to be scanned at checkout**
- **Batteries** – all electronic items must contain new, working batteries.
NEW FOR SPRING '26 – Replacement battery charges:
 - o **\$2/per AA or AAA battery**
 - o **\$3/per 9-V, C or D battery**
- **NEW FOR SPRING '26** – We reserve the right to charge **15%** of tagged price for items that do not meet our quality expectations and require cleaning by the Quality Team in order to be sold. The fee of **15%** of the tagged price will be deducted from the consignor's earnings. Cleaning items at the sale is not guaranteed. Consignors are expected to drop off items that are gently-used and sale-ready. If the item is found to need more than a light cleaning, it will be pulled from the sales floor.
- **Returned Items – 40% of the selling price** – While all sales are final at WeeUsables Consignment Events, there are extenuating circumstances in which, based on the sole discretion of WeeUsables, a full return and refund is warranted based on a sold product not meeting the consigning guidelines, standards, and what to sell rules. In these instances, WeeUsables will be retaining a 40% fee of the original selling price of the returned item. This 40% fee will be deducted from the seller's consignor earnings that is paid out at the end of the sale.

TOTAL ITEM & CATEGORY QUANTITY LIMITS

Below is a list of total item and category quantity limits at WeeUsables events.

- **500 TOTAL item limit**
 - Each initial consignor registration fee allows for up to 500 TOTAL inventory items.
 - See below for specific hanging clothing limits within the overall item count.
 - This limit applies at Lancaster, York, and Holiday only.
 - **NEW FOR FALL '26 - Consignors may choose to enter more than 500 items for an additional \$15 per each 500 entered. Each \$15 fee will be automatically deducted from a consignor's settlement for each 500+ items entered into the system (501+, 1001+, 1501+, etc.). Additional added inventory does not increase hanging and/or other established category limits.**
- **Hanging clothing limits**
 - Each initial consignor registration fee includes the following hanging clothing item limits, within the overall item limit:
 - **Lancaster, York, and Holiday Only (500 TOTAL ITEM LIMIT):**
 - **200 hanging "Boys Clothing" and**
 - **100 hanging "Girls Clothing"**
 - *PLUS* Hanging "freebies", i.e. hung PJs, outerwear, swimwear (spring only) & costumes
 - All hanging Boys, Girls & "Freebie" Clothing count towards the overall 500 item limit.
 - You must utilize the proper categories and designated "freebies" when entering items in order to avoid unnecessary charges.
 - **Harrisburg Only (NO TOTAL ITEM LIMIT):**
 - **Unlimited hanging "Boys Clothing" and**
 - **200 hanging "Girls Clothing"**
 - *PLUS* Hanging "freebies", i.e. hung PJs, outerwear, swimwear (spring only) & costumes
 - You must utilize the proper categories and designated "freebies" when entering items in order to avoid unnecessary charges.
 - See below for allowances of additional hanging in Boys & Girls categories.
- **No additional hanging "Boys Clothing" available**
 - All hanging boys clothing is limited to 200 maximum.
 - This limit applies at Lancaster, York & Holiday only.
- **\$15 – for over 100 hanging "Girls Clothing" items entered**
 - Consignors may choose to consign up to 200 hanging "Girls Clothing" items for an **additional \$15**. This fee will be automatically deducted from a consignor's settlement for **101+ items entered (101-200)** into the "Girls Clothing" category. The system will not warn you when over 100 items are in this category. You must monitor your account levels.
 - This limit applies at Lancaster, York & Holiday only.
 - This charge does *NOT* increase a consignor's TOTAL item limit.
- **Maximum of five (5) hanging maternity items**
- **NEW FOR FALL '26 - Books are limited to (100) in Lancaster and (75) in York and Harrisburg - please bring your best!**
- **Maximum of five (5) identical items** (size, design, and manufacturer) allowed per consignor

- **NEW FOR SPRING '26 - Maximum of five (5) new or gently used Art Supplies at York or Harrisburg locations. Maximum of ten (10) at Lancaster location only.**
- **Maximum of five (5) puzzles over 300+ pieces**
- **NEW FOR FALL '26 - Hair Accessories are limited to ten (10).**

WHAT TO SELL: SEASONAL EVENTS

CLOTHING CATEGORY FOR SEASONAL EVENTS

(All in NEW or GENTLY-USED condition unless otherwise noted.)

Acceptable Clothing

- ✓ Kids' brands clothing in sizes preemie to kids 20
- ✓ **Maternity clothing in adult sizes—Limit five (5) items per consignor**
- ✓ School uniforms, sports and athletic clothing, dress-up / costumes and handmade items which adhere to the current CPSC guidelines
- ✓ Clothing with non-numerical size (i.e. S, M, L and XL...MUST enter corresponding numeric size on price tag)
- ✓ Swimwear - inside lining may be removed on boys' swim trunks (must be noted on tag) **allowed at spring events only; competitive swimwear allowed at all events**
- ✓ Heavy winter outerwear/gear, winter gloves, winter hats, winter coats or snow boots **allowed at fall events only**
- ✓ Boys and girls accessories (i.e. ties, jewelry, hair items, etc.)
- ✓ Undergarments (i.e. onesies, undershirts, camis, bras, nursing bras, bloomers, cartwheel shorts, training pants* and underwear*)
 - ALL clothing must be hung except socks, tights, new underwear, new training pants, bras, nursing bras, bloomers and swaddles
 - ***Note:** All training pants and underwear must be NEW, in original packaging

Unacceptable Clothing

- ✗ Swimwear **not allowed at fall events**
- ✗ Junior-sized clothing and adult clothing (other than maternity)
- ✗ Stained, torn, old, smelly, smoky, moldy or pet-hair covered items
- ✗ Items with illegible or missing manufacturer's size information
- ✗ Used underwear and training pants
- ✗ Items with adult/mature graphics, wording or themes
- ✗ **NEW FOR SPRING '26** - Keychains and Lanyards
- ✗ **NEW FOR FALL '26** - Kids' Belts
- ✗ **NEW FOR FALL '26** - Dance/Recital Costumes

SHOE CATEGORY FOR SEASONAL EVENTS

(All in NEW or GENTLY-USED condition unless otherwise noted.)

Acceptable Shoes

- ✓ Sizes: baby 0-24 months, toddler up to size 13, big kids 1-8+
- ✓ Kid-appropriate styles such as dress shoes, sneakers, dance shoes, rain boots, water shoes, flip flops, sports shoes/cleats*
- ✓ Unlined Crocs and athletic slides allowed at all seasonal events
- ✓ **Spring Events Only:** Warm weather footwear (i.e. flip flops, summer-style sandals, water shoes)
- ✓ **Fall Events Only:** Cold weather footwear (i.e. snow boots, lined boots)

- ✓ **NEW FOR SPRING '26** - Gently-used Robeez-type infant shoes **only** may be sold in original box
 - ***Note:** Sports shoes / cleats must be entered under "Sports Equipment" for tagging but are placed with shoes on the sales floor.

Unacceptable Shoes

- ✗ Warm weather footwear (i.e. flip flops, summer-style sandals, water shoes) **not allowed at fall events** and cold weather footwear (i.e. snow boots, lined boots) **not allowed at spring events**
- ✗ Adult styles/designs
- ✗ Dirty, scraped, scuffed, dented, overly worn shoes
- ✗ Frayed laces or unclear Velcro
- ✗ Overly-worn treads
- ✗ **NEW FOR SPRING '26** - Shoes in boxes, unless Robeez-type in original box
- ✗ **NEW FOR SPRING '26** - Track Cleats (spikes)

OTHER CATEGORIES FOR SEASONAL EVENTS

(All in NEW or GENTLY-USED condition unless otherwise noted.)

Acceptable Non-Apparel Items

- ✓ **Baby/toddler travel equipment** (i.e. car seat with base*, additional bases*, booster seats* and accessories, pack-and-plays*, diaper bags, carriers/wraps/slings, strollers* and accessories etc.)
 - ***Note:** Car seat with base, additional bases and booster seats will need to have a document signed by the consignor verifying that the item(s) have not been in any accidents, have not expired per the manufacturer's printed date and at least six (6) months remain until the expiration date; if the item does not have a visible expiration sticker, the manufacturer's date must be less than **six (6) years old**.
 - ***Note:** Pack-and-plays must have their original manufacturer-issued liner and/or mattress, mattresses not manufactured with original pack and play may not be sold.
 - ***Note:** Strollers must have a three (3) or five (5) point harness and be manufactured after 2/2013.
 - ***Note:** All safety straps must be original or a manufacturer-approved replacement.
- ✓ **Nursery/children's furniture** (i.e. cribs*, changing tables, gliders, rockers, nursing stools, bassinets*, crib mattresses, co-sleepers*, table and chair sets, children's chairs/stools, wood/toy chests*, etc.)
 - ***Note:** Cribs must be manufactured after 6/2011 and without a current recall and must include hardware.
 - ***Note:** Bassinets must be manufactured after 4/2014 and co-sleepers must be manufactured after 7/2014.
 - ***Note:** See **anchorit.gov** for tipping hazard guidelines.
 - ***Note:** Wood/toy chests must have soft close hinges and air holes or no locking mechanism.
- ✓ **Baby equipment*** (i.e. bouncy seats, exersaucers, jumperoos, swings, activity mats, walkers, high chairs*, booster seats, etc.)
 - ***Note:** Baby equipment must have all safety straps attached; straps must be original or a manufacturer-approved replacement.
 - ***Note:** High chairs must have a three (3) or five (5) point harness, unless a two (2) point harness has a raised barrier between the legs.
 - **All new and used baby equipment and furniture must be unboxed and assembled prior to selling.**

- Baby equipment includes: pack-n-plays, strollers, cribs, changing tables, bassinets, bouncy seats, exersaucers, jumperoos, swings, walkers, etc.
- ✓ **Outdoor toys** (i.e. bikes, scooters, riding toys, playhouses, motorized cars, power wheels*, etc.)
 - o ***Note:** Power wheels must be fully charged at drop off AND must include a charging cord
- ✓ **Sports equipment** (i.e. bats, balls, helmets, skates, protective gear, attachable bike seats* and bike trailers*, competitive swimwear, etc.)
 - o ***Note:** Attachable bike seats and trailers must include hardware
- ✓ **Art supplies** (i.e. sewing items, craft kits, coloring materials, jewelry making materials, new playdough and accessories, etc.) - limit to 10 in Lancaster and 5 in York and Harrisburg
- ✓ **Games and Puzzles** (must be complete and kid-oriented, limit: maximum of five (5) puzzles over 300+ pieces)
- ✓ **Electronics/video games and accessories** (i.e. games must be rated “E” for Everyone through “T” for Teen; gaming accessories include headphones, controllers, docks, chargers, cases, etc.)
- ✓ **Books** Only use removable painter’s tape to secure tags, no packaging tape or adhesive tags on books - limit to 100 in Lancaster and 75 in York and Harrisburg
- ✓ **Safety and Child-proofing equipment** (i.e. gates, door handle and cabinet locks, monitors, outlet covers, etc.)
- ✓ **Feeding items** (i.e. sippy cups, utensils, travel containers, baby food-making appliances, bibs, etc.)
- ✓ Bottles, nipples, bottle warmers, travel bags, nursing covers, non-liquid filled teethingers, open-style pacifiers, nursing pillows, new/unopened and unexpired nipple creams, breastmilk storage and accessories, breast pumps that are NEW and SEALED in original manufacturer’s packaging.
- ✓ **Diaper and Potty-Training items** (i.e. disposable diapers, diaper genies, NEW training pants in original packaging, clean potty seats, wipes, wipe warmers, new/unopened and unexpired diaper rash cream, etc.)
- ✓ **Bathing items** (i.e. bath seats or infant bath supports, towels, new/unopened and unexpired bath products, bath toys that cannot trap water or NEW squirt toys still in original packaging, etc.)
 - o **Bathtubs must include attached manufacturer-issued warnings about drowning AND falling risks; Bathtubs must include a stamped manufacturer date of October 2017 or newer.**
 - o ***Note: Bath Seats must have small leg hole openings. (Please check the CPSC website as some bath seats are currently recalled.)**
- ✓ **Bedding items** (i.e. mattress protectors, crib/toddler and, **complete twin sheet sets** with intact elastic, breathable bumpers, receiving blankets, single-layer blankets, new “lovies”*, sleeping bags, etc.)
 - o ***Note:** A lovey (stuffed animal with small blanket attached) must be in original packaging or include an attached manufacturer’s tag.
- ✓ **Organizational/storage and room décor with a functional purpose** (i.e. closet organizers, storage bins/containers, lamps, night lights, curtains, banks, bookends, etc.)
- ✓ **Kid-oriented seasonal holiday items** (i.e. Halloween trick-or-treat bags, holiday stockings, Easter baskets, eggs, etc.)
- ✓ **NEW FOR FALL ‘26 - Stuffed animals under 20” tall** that light up, play music/sound, vibrate, dance or rattle; character plush dolls (i.e. Disney characters, superheroes, etc), Squishmallows and Build-A-Bear only

Unacceptable Non-Apparel Items

- ✗ **Recalled items* – Check here for recalled items.**
 - o ***Note:** Recalled items may be sold ONLY if there has been an approved repair and the manufacturer’s repair kit was installed properly
- ✗ **Car seats older than the printed manufacturer expiration date** OR, if no printed sticker, not older than six (6) years from the manufactured date OR a car seat that expires within six (6) months of the sale date; also, no car seat liners without a car seat

- ✖ **Cribs manufactured on or before 6/2011** and any with an adjustable/drop side
- ✖ **Pack and plays without their original liner or mattress** (In addition, no pack and play mattresses or liners may be sold separate from their originally intended pack and play)
- ✖ **Wood Changing Table Toppers that are placed on a small dresser**
- ✖ **Battery-operated items without functional batteries***
 - o ***Note:** Items that are new, in box or original packaging do not need to include batteries. Batteries that stop working at the sale will be charged a battery fee (paid by consignor) if the item is found not working
- ✖ **Mouth guards, vampire teeth, kazoos, whistles, noise makers and any items that would enter the mouth** (unless new, in original packaging)
- ✖ **Sophie the Giraffe Teether (unless NEW in original packaging)**
- ✖ **NEW FOR FALL '26 - Stuffed animals or plush toys** that don't light up, play music/sound, vibrate, dance or rattle, etc. **No Violet or Scout interactive plush animals manufactured by LeapFrog, VTech or Fisher Price. No large/jumbo stuffed animals over 20".**
- ✖ **NEW FOR FALL '26 - Backpacks regardless of size (Kid-oriented purses and bags - OK)**
- ✖ **Porcelain dolls and tea sets**
- ✖ **Naked dolls** (i.e. Barbies, baby dolls, etc. must have clothes)
- ✖ **Magnetic dress up dolls and magnetic beads**
- ✖ **Easy-Bake Ovens**
- ✖ **Pop-Its**
- ✖ **Water Beads**
- ✖ **Broken, incomplete or overly-used toys, games and puzzles**
- ✖ **Silly putty, slime, kinetic sand or playdough** (unless new, in original packaging)
- ✖ **Video game figurines** (i.e. Skylanders)
- ✖ **NEW FOR SPRING '26 - Screen & device protectors**
- ✖ **NEW FOR SPRING '26 - Any used device that requires user-registration** (i.e. laptops, smart watches, tablets, Tonie Box/Speakers (Tonie accessories are still allowed), etc.
- ✖ **Video games and electronic accessories** that are outdated/discontinued and/or are no longer maintained or supported by their developer
- ✖ **Video games rated "M" for Mature**
- ✖ **CDs, DVDs, audio books, VHS tapes and cassettes**
- ✖ **Cell phone cases and screen protectors**
- ✖ **ALL ingestible items** (i.e. medicine, vitamins, food and formula, etc.)
- ✖ **Self-feeders**
- ✖ **Liquid-filled teethers and used "closed" pacifiers** (unless new, in original packaging)
- ✖ **Breast pumps and tubing** (unless NEW and SEALED in original manufacturer's packaging)
- ✖ **NEW FOR FALL '26 - Maternity Body Pillows**
- ✖ **Bath products** (unless new, in original packaging and not expired)
- ✖ **NEW FOR FALL '26 - Used Makeup**
- ✖ **Otteroo's or similar "neck flotation" items**
- ✖ **Nail polish** (unless new, in original packaging)
- ✖ **Humidifiers, vaporizers or nasal aspirators** (unless new, in original packaging)
- ✖ **Squeeze or squirt bath toys and/or any item which could hold or trap water** i.e. dolls, sprinklers, water guns, baby activity mats (unless new, in original packaging)
- ✖ **Decorative room décor without a functional purpose** (i.e. statues/figurines, rugs, decorative or character pillows, pictures/wall hangings, photo frames/albums, etc.)
- ✖ **NEW FOR FALL '26 - Coin banks (porcelain, glass or ceramic)**
- ✖ **Lava lamps and snow globes**
- ✖ **Large mirrors or magnifying/makeup mirrors**
- ✖ **Pillows or pillow pets that do not "DO" something** (i.e. light up, vibrate, play music/sound, etc.)
- ✖ **"GIFTABLES"** (i.e. items that are new-in-packaging but are not on our acceptable items list)
- ✖ **Cloth diapers and cloth swim covers**
- ✖ **Diaper holders** made of cloth that hang, usually by a hook or hanger

- ✖ **Weighted items including blankets, quilts, comforters, multi-layer blankets or sleep sacks**
- ✖ **Any device that monitors infant breathing or vitals including Owlet Ankle Socks**
- ✖ **Crib bumpers that are not mesh/breathable**
- ✖ **NEW FOR FALL '26 - Crib skirts**
- ✖ **Sleep positioners, wedges or Dock-A-Tot like items**
- ✖ **Crib mobiles**
- ✖ **"Lovies" (unless new in original packaging, taggies, crinkle or has a rattle)**
- ✖ **Invitations and party supplies**
- ✖ **Sewing patterns, balls of yarn and cloth/material**
- ✖ **Vintage or antique items**
- ✖ **NEW FOR SPRING '26 - Twin or larger mattresses**
- ✖ **NEW FOR FALL '26 - Twin or larger bed frames**
- ✖ **NEW FOR FALL '26 - Sheet sets larger than Twin**
- ✖ **NEW FOR FALL '26 - Single pillowcases, sheets (i.e. all sheet sets must be sold complete)**

WHAT TO SELL: HOLIDAY EVENTS

HOLIDAY SALE ACCEPTABLE ITEMS

- ✓ **All items normally accepted at one of our FALL sales ARE accepted, unless noted otherwise.**
- ✓ **Men's Hanging Clothing** - limit 50 items.
- ✓ **Women's & Juniors' Hanging Clothing** - combined limit of 50 items, enter Juniors' clothing under "Women's Clothing" in the inventory entry system.
- ✓ **Boys & Girls Hanging Clothing** - seasonal item & category limits apply.

ITEMS LISTED BELOW MUST BE NEW (in packaging, with original tags or sealed):

- ✓ **JUNIORS', WOMEN'S, and MEN'S ACCESSORIES** (including hats, gloves, scarves, socks, wallets, money clips, ties, makeup, and makeup bags/cases)
- ✓ **GIFTABLE ITEMS** (including kitchen appliances and kitchen items, coffee makers and accessories, bed & bath items, throw blankets, pillows, tools, grilling sets, coolers, lotions, soaps, candles, perfumes, travel supplies, luggage, pet items, wrapping paper, gift bags and tags, etc.)

ITEMS LISTED BELOW MAY BE NEW OR GENTLY USED

- ✓ **JUNIORS' and WOMEN'S CLOTHING** (general winter clothing including dresses and dressy shirts/pants, jeans, outfits, snow wear, coats, jackets, sweaters, leggings/pants, athletic wear, pajamas and made of thermal, flannel, corduroy, velvet, velour, fleece, sherpa and wool)
- ✓ **MEN'S CLOTHING** (including sweaters, slacks, jeans, athletic wear, jackets, snow wear, coats, flannel and dress/polo shirts)
- ✓ **JUNIORS', WOMEN'S, and MEN'S ACCESSORIES** (including purses, wristlets, sunglasses, jewelry, jewelry boxes/containers, hair accessories)
- ✓ **"UGLY" HOLIDAY SWEATERS** ANY holiday for the whole family
- ✓ **HOLIDAY FAMILY PAJAMAS** ANY holiday for the whole family
- ✓ **COSTUMES** only winter holiday costumes (i.e., Santa, elves, snowman, reindeer, etc.) and Disney characters
- ✓ **JUNIORS', WOMEN'S, and MEN'S SHOES** (i.e., dress shoes, sneakers, slippers, all varieties of boots, etc.)
- ✓ **STUFFED ANIMALS** (they do not have to "do something")
- ✓ **HOLIDAY DECOR and HOUSEWARES** ANY holiday
- ✓ **GIFTABLE ITEMS** (i.e., Pro and Collegiate sports memorabilia and fan gear, collectibles, warmers and plug-ins, bar accessories, home office organizers, earbuds/headphones, etc.)
- ✓ **NEW FOR HOLIDAY '26 - VIDEO GAMES** - Rated up to and including "M" for Mature

HOLIDAY SALE UNACCEPTABLE ITEMS

- ✗ **CHILDREN'S, JUNIORS', WOMEN'S or MEN'S** swimwear, even if new with tags
- ✗ **DVDs** - even if new, unopened
- ✗ **VINTAGE or ANTIQUE ITEMS**

- ✖ **BOOKS** - Adult-themed
- ✖ **NEW FOR HOLIDAY '26 - DECORATIVE / ACCESSORY SCARVES (Cold weather scarves allowed)**
- ✖ **NEW FOR HOLIDAY '26 - WOMEN'S, MEN'S, AND JUNIOR'S BELTS**
- ✖ **NEW FOR HOLIDAY '26 - KEYCHAINS AND LANYARDS**
- ✖ **NEW FOR HOLIDAY '26 - GENERAL DECOR WALL ART (Holiday/Seasonal/Children's Wall Art allowed)**
- ✖ **NEW FOR HOLIDAY '26 - PARTY SUPPLIES AND DECORATIONS**
